I write again following the Prime Minister's announcement of new measures to help control the spread of Coronavirus. From midnight on the 5th November the country began a new national lockdown.

The Government is constantly monitoring the spread of covid19 in our communities and will seek to ease restrictions according to the latest data and trends.

Personal Finance, Business and Self-Employment Support:

To continue to protect the financial well-being during this time, the Government has announced further support measures for both <u>individuals</u> and <u>business</u>:

- An extension of the <u>Coronavirus Job Retention Scheme</u> further, until the end of March 2021.
- An increase to the self-employed grant up to 80 per cent of trading profits.
- Extend existing loan schemes to the end of January and an ability to top-up Bounce Back Loans.
- Cash grants of up to £3,000 per month for businesses which are closed in England.
- £1.1 billion for councils in England to further support businesses more broadly over the coming months.
- An extension to the mortgage payment holiday for homeowners.
- Providing councils in England with up to £500 million of funding to support the local healthcare response.
- Over £200 billion on VAT relief, business rate relief, loans, tax deferrals, and support for individuals.
- Additional funding of £2.7 million has been granted to Norfolk County Council, as part of the £170 million winter support package for vulnerable families.

Local Support and Norfolk County Council

All Norfolk MPs and local services are working closely together to help everyone. Norfolk County Council is taking the lead for Covid-19 response in Norfolk with relevant details, regular updates and key information on <u>accessing support</u> and information for <u>care providers</u>.
