### **Update 11 December 2020**

#### **Local Coronavirus figures**

The current local Coronavirus figures can be found on the Government website:

The figures yesterday were:

- For the time period 29/11/2020 to 05/12/2020 the Norfolk seven-day incidence per 100,000 is 102.3, East of England is 141.8 and England is 153
- RED incidences are for Breckland with an incidence rate per 100,000 of 74.3, Broadland 107.8, Great Yarmouth 138.9, King's Lynn and West Norfolk 95.8, North Norfolk 72.5, Norwich 122.4 and South Norfolk 108.6.

The figures last week were:

- For the time period 22/11/2020 to 28/11/2020 the Norfolk seven-day incidence per 100,000 is 87.8, East of England is 115.2 and England is 155.4
- RED incidences are for Breckland with an incidence rate per 100,000 of 57.2, Broadland 120.1, Great Yarmouth 79.5, King's Lynn and West Norfolk 85.9, North Norfolk 55.3, Norwich 111.0 and South Norfolk 97.3.

#### **Tiering**

Norfolk County Council have issued a press release reminding everyone that the whole of Norfolk is in Tier 2 – High Alert. The restrictions that apply in Tier 2 are available on the [Government website](#). It is vital that we all continue to follow the guidelines to help protect each other and protect west Norfolk.

This comment in the NCC press release, sums things up very well:

Dr Anoop Dhesi, a practicing GP at Staithe Surgery in Stalham and Clinical Chair for NHS Norfolk and Waveney Clinical Commissioning Group (CCG) says: "It's great news that we have started vaccinating against COVID-19. We have started with the most vulnerable people, but vaccinating everyone will be a marathon not a sprint.

"We must all remember that this pandemic has not gone away. Covid infection rates remain high and are higher now than when we went into the second lockdown. Local hospitals are under great pressure and are seeing very sick COVID patients alongside the usual winter pressures.

"We can see light at the end of the tunnel. But we should remember that the virus does not understand our frustration at not being able to be with our friends and families, and it is not sentimental about Christmas. Its only purpose is to replicate by spreading from one person to another, causing misery and death in its wake. So we must protect ourselves and help the NHS cope this Christmas by following the local tier guidelines - including washing our hands, wearing face coverings and staying two metres apart.

"Over the coming weeks and months people will be invited when it's their turn to be vaccinated. Do not ask your GP or hospital, please wait for your invite."

### **Vaccination programme**

In addition to Dr Anoop Dhesi's comments above, we must remember the following points:

The vaccination programme is being led by NHS England and locally by the CCG. Any communications will come from them. There are many rumours, so if you do receive enquiries please refer people to the CCG in the first instance - [nwccg.communications@nhs.net](mailto:nwccg.communications@nhs.net).

If members of the public want more information, the CCG have created a [web page with frequently asked questions](#) to which you can direct people.

The key message is that people will be informed when it is their turn, so they need to be patient and wait for their invitation, the number of doses is limited at the moment and priority groups as set out by the Government and NHS will be vaccinated first.

### **Walk-in test centre at Lynnsport**

Hopefully you are all aware of the walk-in test centre at Lynnsport. It has come to our attention that people have still been travelling to Peterborough for tests when they could have gone to King's Lynn. If you or a member of your family need to book a test and you want to use King's Lynn, you need to select walk in on the booking portal, rather than drive in, then Lynnsport, King's Lynn will come up as an option. We will be including this in our external messaging about the test centre.

### **Communications over the next few weeks**

A county-wide campaign launched on Monday and the materials are being used on our social media sites and at bus stops. The key messages are reminded people to shop at less busy times, to order locally, and not to shop with groups of friends. There is also a suite of materials encouraging people to socialise sensibly, meeting in groups of 6 or less outside, or organising online celebrations instead of the usual meals out with friends. Please do support the campaign by sharing these materials on your own channels.



### **Carol services**

Some information about carol services/concerts that may be of interest to you:

- Indoors - only choir allowed to sing, congregation in family groups or socially distanced.

- Outdoors - choir and other participants can sing but must be in household groups (+Christmas bubbles between 23-27 December) or socially distanced as per current restrictions.
